- Grandstand T 1: 18 rows (row 7-24) 34,50 m in length, 14,40 m in depth elevation 30 cm / row first row at 215 cm height 2 stairways from behind 1222 seats
- Grandstand T 2: 18 rows (rows 4-21) 70,50 m in length, 14,40 m in depth elevation 30 cm / row first row at 125 cm height 5 stairways from the front 2502 seats
- Grandstand T 4: 27 rows (rows 4-30) 25,50 m in length, 21,60 m in depth elevation 30 cm / row first row at 125 cm height 2 stairways from behind 1290 seats
- Grandstand T 6: 18 rows (rows 7-24) 25,50 m in length, 14,40 m in depth elevation 30 cm / row first row at 215 cm height 2 stairways from behind 849 seats

## **Terms and Conditions**

## According to the terms and conditions mentioned in the tender

- In the event that the contractor does not meet the deadline set within the individual stages of fulfilment of the public contract the contractor pays the principal a contractual fine of 0.2% of the contractual price of these supplies (excluding DPH) for each day or started day of delay by the contractor in fulfilling the public contract. These provisions do not affect the right to compensation for damage.
- 2. The contractor proceeds with professional diligence, follows legal and other regulations relating to the subject of the contract including valid technical standards. The principal has the right to inspect the implementation of the supplies in all stages of realisation.
- 3. The contractor affirms and with his signature confirms that as of the day of concluding the contract:
  - a) it is insured against liability for damage arising from implementation of the supplies and undertakes that it will be so insured throughout the period of the contract of obligations arising from the contract in the minimum amount of CZK 3.000.000
  - b) it is not being wound up
  - c) it is not the subject of insolvency proceedings and is not in a situation where this is anticipated
  - d) it is not listed in the register of unreliable VAT payers
- 4. The contractor undertakes properly and in time to fulfil its duties relating to the administration of VAT throughout the duration of the contract, and especially to pay this tax correctly and in time. If as a result of the breaching of this obligation the relevant Tax Office calls on the principal to pay the VAT due to its acting as a guarantor in the sense of this point, the contractor undertakes to pay the principal a single contractual penalty in the amount of the VAT related to the breach of the obligation by the economic operator to pay VAT correctly and in time, with which the principal's guarantee is associated.
- 5. The price of the fulfilment of the public contract will be paid on the basis of invoices issued after the completion of the work in accordance with the commercial terms and conditions.
- 6. The due date for invoices will be 30 calendar days after their demonstrable delivery to the contracting entity.
